## What to Bring to Camp



#### What to Pack:

- Water bottle
- Coast Guard approved PFD
- Sunscreen & swim shirt
- Swimsuit, towel, and goggles
- Morning snack
- Lunch (or sign up for lunch plan!)
- Hat
- Change of clothes
- Appropriate footwear for activity

#### **What Should Stay Home:**

- Stuffed animals and blankets
- Toys of any kind
- Electronics (cell phones, iPods, Gameboys etc.)
- Nut products
- Pokémon Cards


#### **Lost and Found**

Our staff is not responsible for lost or missing items. We kindly ask that all of the items your child brings to camp are clearly labeled with initials or their last name. We have one designated lost and found bucket. We encourage your camper to be responsible for keeping track of their personal belongings. No toys or special items should be sent to camp.

## **Camper Identification**

We require all campers to wear a pinnie while in Pre-Primary camp. We use pinnies to help differentiate campers from other members at the Waeg. We will be sending campers home with their pinnie each day to provide greater parental/guardian control over your campers' individual health and hygiene! Campers will receive their pinnies on Monday, and they will be collected on Friday. To ensure your child's safety, your campers should arrive to camp each day with their pinnie on. Additionally, please note that the pinnies are washing machine and dryer safe!

### **Swimming & Tennis Lessons**

If your child is enrolled in tennis or swimming programming while in camp, we will have one of our camp counsellors walk them to and from each lesson to ensure safety and punctuality. For Pre-primary camp, campers are only able to register for 1 programming event within a week. Therefore, we ask you do not register your child(ren) for both swimming and tennis within the same week. Our counselors will be equipped with a schedule containing times/location to make sure your camper(s) is dressed and ready for their lesson!

If you plan to register your camper(s) for youth programming, please register between **the camp friendly hours of 9:30am and 11:30am**. Can't find a lesson/level during the camp friendly times? Please reach out to us first before registering for a lesson outside of the camp friendly hours. We are here to help!

\*Please note that all regular programming runs for 2-week sessions, while Camp operates weekly.

#### Media




#### **Photos**

# WAEG CAMP BEHAVIOR



- !. Talk with positive language! Foul language, put downs and bullying will not be accepted.
- 2. Be safe! Always obey camp rules, pool rules and staff.
- 3. Treat all equipment and supplies with proper care and respect.
- 4. Running and excessive shouting while <u>indoors</u> is not allowed.
- 5. Aggressive behavior that is threatening to the child, staff or others will not be permitted at camp.
- 6. Have a positive attitude and have fun!

Listed below are the disciplinary procedures for campers who are exhibiting unacceptable behavior.

Depending on the severity of the behavior, we may skip a particular step. (I.e. aggressive behavior will not be tolerated.)



Incident 1: Verbal Warning- Counselor will go over the behaviour with the camper(s) to discuss why it might be disruptive/harmful for other campers or staff and what we can do to make it right!

Incident 2: Alternate Activity- Camper(s) may be removed from activity and provided an alternate activity to allow emotions to regulate. Another conversation will be held between counselor and camper explaining how behaviour can improve.

Incident 3: Written Warning- If behaviour continues, a warning will be given to the parent or gaurdian. Either Sophie or Alex will speak with the child and their parent/guardian at pickup to discuss behaviour and possible solutions. A behavioural incident report will be given that will need to be signed by a parent or guardian and returned to staff.

Incident 4: Meeting- If behaviour persists, our camp cocoordinators will work closely with parent or guardian to provide solutions that seem best-fit for each child to be able to prosper in Waeg Camp. If distributive or violent behaviour continues, the child may be removed from Waeg Camp.

#### **Termination of Childcare Space**

The Waegwoltic Club recognizes that some summer camps are not always appropriate for all children. Many supports are put into place to create a happy and successful placement for all children. In cases of severe behavior issues, it may be necessary to terminate the camper from the childcare space.

A decision to terminate a child's space will be made in consultation with parents. The Waegwoltic Club's priority is for the safety of all children in its programs.

## **Custody Arrangements**

Parents are asked to explain custodial arrangements when enrolling their children into Summer Camp. When special circumstances apply such as denial of access to one parent, we ask that you provide written documentation of custody and access schedules issued by the court.

### **Drugs/Alcohol**

Children will not be released from camp to accompany a parent or guardian who is under the influence of drugs or alcohol. In such circumstances, our Coordinator Samantha, will call the other parent/guardian, or emergency contact listed and request that they come pick up the child.

## **Drop-off & Pick-up Procedures**

Our drop off and pickup area is located in the back-left of the parking lot on the Fairfield side (shown in the map to the right). We have a parking spot designated to solely camp drop off and pickup purposes. For drop off, we invite you to park in the Waeg parking lot and walk your camper down to check-in. Please be advised that you must have your member card with you to be let in. This remains true even if you are coming for solely camp drop off and pickup. We kindly ask that in the case of a non-member picking up or dropping off a camper, that it is prearranged with our Coordinator Samantha, via email: preprimarywaeg@gmail.com.

Our hours for Drop-off and Pick-up are:

**Drop-Off= 8:30am-9:00am Pick-up= 4:00pm-5:30pm** 



#### **Rainy Day**

In the event of rain, Pre-primary camp pick-up and drop-off will take place at the Lily pad (located in the boat house by the Lido).

\*Please note that if you are dropping off/picking up outside of our designated drop-off/pick-up times, you must call the camp phone (902.471.9234) upon your arrival to facilitate a safe transition.

## **Swim Safety**

Camp goes swimming every afternoon and ensuring the safety of our swimmers is paramount. In addition to our 30+ fully qualified lifeguarding staff, our camp counsellors are stationed around the Lido and their camp visors make them identifiable to campers and the general member body.

In accordance with Life Saving Society's recommendations, we no longer allow the use of puddle jumpers in camp. All campers who require aquatic assistance must come to camp with a coast guard certified personal floatation device (PFD). Trust us, lifejackets have come a long way! There are several coast guard-approved PFDs that allow for both comfort and wide range of motion while offering gold standard protection.

## **Swim Bracelets**

Pre-primary camp provides each camper with a vellow bracelet at the beginning of the week. This bracelet informs us and those around us that these campers are required to wear a coast guard approved PFD whenever they are in or around any pools. These bracelets will be given out on Mondays and will be cut off prior to pick up on the Friday.

All pre-primary campers are required to wear a coast guard approved PFD lifejacket no matter of the child's swimming skill.

## Lunch & Snack at Camp

Please be advised that we are a **nut free camp and a nut aware property**. While Camp maintains a nut free environment, the Waegwoltic Club is not a nut free facility. To ensure the safety of our campers with allergies, we ask that you do not send your camper(s) with any nut products.

We have two allocated snack times throughout the day, one in the morning and one in the afternoon. We ask that snacks are brought from home for our morning snack time. The afternoon snack will be provided by the Waegwoltic Club. We ensure that this snack is always healthy, nutritious, and delicious! Pre-primary campers will **not** be able to use the canteen at any point throughout their day at camp.

#### **Lunch Plan**

Camp Waegwoltic offers a Lunch Plan program at a charge of \$50.00/week + tax. Our lunch plan provides campers with a balanced nutritious meal. You can register for this service through your online account or at (902) 429-2822 ext. 2. Registration for lunch plan closes Thursday the week prior at 4pm.



## **Health Precautions**

#### **Camper Care**

Our summer Camp staff are thoughtfully selected and thoroughly trained. Every Counsellor is certified in Emergency First Aid and withhold Vulnerable Sector Police Checks each year. Furthermore, all of our staff are supervised by program coordinators who report directly to Katelyn Matheson, our senior administrator of programming and recreation at the Club. In addition to our core staff, our summer camp also benefits from the supervision of our 30+ fully qualified lifeguarding staff.

#### **Illness Protocol**

The health and well-being of our members and staff is of utmost importance to us. Therefore, if your child is showing symptoms of illness, please make alternate childcare arrangements.

Our "Common Childhood Diseases Chart" has been created by Nova Scotia Health Promotion and Protection we ask you to adhere to the return (to childcare) dates given if your child develops any of the symptoms/diseases listed.

It is necessary that parents develop back up plans for the care of their child in the event of illness.

**Your Child cannot attend the Full-time Camp Programing if they:** 

- Have a temperature of 101 degrees Fahrenheit (38.4 degrees Centigrade) or over.
- Have not been fever free for 24 hours.
- Have vomited while at camp or within the last 24 hours.
- Have diarrhea (abnormally loose, watery bowel movements that are much more frequent than usual).
- Has been on a prescribed medication for less than 24 hours for a condition requiring exclusion from
  the program according to the Communicable Disease Program. Your child must be symptom free and
  able to cope with all aspects of the program, including swimming.
- Has a rash that has not been identified by a physician to be determined as not contagious or that eems to be worsening.
- Has a severe cold with fever, sneezing and heavy nasal drainage that affects their mood and ability to participate in the program.

If your child becomes ill during camp hours, a parent/guardian will be notified immediately to pick up your child. The child will remain in the care of our support staff in the Lily Pad until a parent or guardian arrives.

Please ensure that your member account has the most updated daytime phone number we can reach you at in the event of illness or emergency.

#### **Communicable Diseases and Return Dates**

Colds	Stuffy or runny noses, sneezing, Watery eyes.	When the child can actively Participate in all parts of the program.
Flu	Sore throats, muscular aches, fever; chills, vomiting and Diarrhea can be involved.	When the child can actively Participate in all parts of the program.
Diarrheal Diseases	Abnormal loose stool, cramps	Diarrhea can be infectious. Children should be kept home until diarrhea stops.
Strep Throat	Red and Painful throat. Fever, swollen neck glands, white patches on tonsils.	48 hours after antibiotic treatment
Impetigo	Spreading sores which can develop golden color crusty area. Little dot-like sores spread Around the original sores. Can Appear on the face, hands, legs, Feet, and buttocks.	48 hours after antibiotic treatment.
Chicken Pox	Very itchy rash starts with pink bumps. Watery discharge.	5-6 days after rash appears or When the chicken pox are all scabbed over.
Pertussis (Whopping Cough)	Intermittent spasms of coughing; leads to chocking and/or vomiting causing reddening in the face	5 days after antibiotic Treatment.
Hepatitis	Viral infection of the intestinal tract. Cause fatigue and nausea, flulike symptoms.	One week after illness Appears.
Mumps	Large swelling from the face to neck, jaw and in front of the ears. Often accompanied by cold like symptoms.	9 days after swelling Begins.
German Measles	Fever, cold-like symptoms followed by a fine rash, swollen glands behind the ears.	5 days after rash appears.

#### **Allergies**

Regarding allergies, if your child carries an EpiPen, camp staff will collect it at the beginning of each day, and it will remain in possession of your child's counsellor for the entirety of the day. In addition, at the beginning of the week, your camper will be given an Epi-pouch that clips on to the outside of your campers' bag. The Epi-pouch may travel to-and-from home with your camper, and camp staff will collect the Epi-pouch at the end of each week. This procedure guarantees that your child's medical device is always accessible.

If you have indicated on the general camper information form that your camper has an allergy or medical condition, you will receive a follow-up email to give you the opportunity to provide more information about your campers' medical requirements and/or preferred accommodations. In the event of a medical emergency: lifeguards, parents/guardians, and first responders (if necessary) will be notified immediately.

#### **Head Lice**

Head lice is a rite of passage we all hope to avoid. Camp Waegwoltic recognizes that head lice is a concern, and we make every effort to prevent the spread of lice. As a result, Camp Waegwoltic has implemented policies in an aim to reduce the spread of lice at camp.

Firstly, our lice motto is 'Hair Up, Hats On!'. If your camper has long hair, their hair should be pulled back prior to arrival at camp each day. Additionally, we encourage all participants to wear a hat during the day not only to reduce the spread of lice, but also for sun protection! Secondly, no stuffed animals or blankets from home will be allowed to come to camp as these items can be carriers.

Finally, we want to encourage communication about lice. We ask that you notify the Camp Coordinators, Samantha, if your child has lice at **any point throughout the summer**. Please help us reduce the spread of lice by keeping up communication with us. We have an open-door policy, and we respect everyone's privacy!

#### **Ticks**

Everyone who spends time outside in Nova Scotia is at risk of being bitten by a tick. While the Waeg's maintenance team has surveyed the property and the counselling staff are aware of what to look for, we encourage parents/guardians to perform at-home checks. ## **Sun Safety**

We apply sunscreen three times throughout the day:

- 1) after morning snack
- 2) after lunch
- 3) in the afternoon after swimming.

**Campers must arrive at camp with sunscreen on** as we do not re-apply until morning snack. We ask that you label your child's sunscreen. This is aimed at reducing the amount of lost sunscreen.

#### **Safety Precautions**

Sunscreen is an important safety measure that can result in close contact between your child and their counsellor. If your camper requires additional assistance to apply sunscreen, their counselor will help with application. We recommend sending your camper with spray sunscreen as it tends to be more child-user friendly.

#### **High Risk Exposure**

Over time, we have identified that swim time is when campers are at the highest risk of sunburn. In accordance with Sun Safety Nova Scotia and their recommended guidelines, we strongly encourage that campers bring a swim shirt to camp every day. This will significantly reduce the likelihood of your child being subjected to excessive sun exposure.
